Introduction:

Builders Merchant Building Index



This **Builders Merchant Building Index (BMBI)** report contains data from GfK's ground-breaking Builders Merchants Panel, which analyses data from over 88% of generalist builders' merchants' sales throughout Great Britain. GfK's Builders Merchant Point of Sale Tracking Data sets a gold standard in reliable market trends. Unlike data from sources based on relatively small samples or estimates, or sales from suppliers to the supply chain, this up-to-date data is based on actual sales from merchants to builders and other trades. It's therefore a very good proxy for housing RMI.

The monthly series tracks what is happening in the market month by month and includes an in-depth review every quarter. BMBI Index data is calculated on the 12-month base period January 2019 to December 2019.

88% coverage of the market



As part of its ongoing drive to ensure the most accurate and relevant understanding of market coverage GfK conducts universe studies every few years.

These studies aim to understand the number of retailers / merchants and the branches they have in a defined universe - in this case the mainland Great Britain Builders Merchants channel.

The previous iteration of the BMBI used a universe study conducted in 2019, with coverage then estimated at 82% was revised up to 92% in the October 2023 report with the introduction of CMO, Huws Gray and JT Dove.

GfK has since completed its latest universe study for the channel and now estimates coverage to sit at 88%.

Overview - 1



August 2024 value sales were -5.6% down compared with August last year

Now based on 88% of actual sales in the market (see page 7), Total Builders Merchants value sales were down -5.6% in August 2024 compared with the same month last year. Volume sales were -5.7% lower and prices flat (+0.2%). Seven of the twelve categories performed better than Total Merchants, led by Services (+2.5%), Workwear & Safetywear (+2.3%) and Decorating (+0.2%). The two largest categories Heavy Building Materials (-6.1%) and Timber & Joinery Products (-8.2%) were weaker than Total Merchants. Renewables & Water Saving (-30.8%) lagged other categories. With one less trading day this year, like-for-like value sales (which take trading day differences into account) were down -1.1%.

August 2024 v July 2024

Total Merchants sales were -8.1% lower in August than in July 2024. Volume sales were -9.2% down and prices were +1.2% up. All categories sold less. Services (-4.4%), Timber & Joinery Products (-7.4%) and Decorating (-7.5%) fell less than Total Builders Merchants. Plumbing Heating & Electrical (-10.0%), Renewables & Water Saving (-11.3%) and Workwear & Safetywear (-14.7%) were the worst performing categories. With two less trading days this month, like-for-like value sales were up +0.7%.

August Index:

August's overall BMBI index was 116.8. Eleven of the twelve categories exceeded 100. Seasonal category Landscaping (134.3) was up the most followed by Decorating (122.9), Services (122.0) and Workwear & Safetywear (121.0). Renewables & Water saving (113.5), Tools (111.2), Kitchens & Bathrooms (110.8), Timber & Joinery Products (109.0), Ironmongery (106.7), and Plumbing Heating & Electrical (102.8) indexed less than Total Builders Merchants. There was no difference in trading days.

Latest three months v last year: June 2024 - August 2024 v June 2023 - August 2023

Total sales in June to August 2024 were -6.6% lower than the same period last year. Volume sales were down -7.6% and prices up +1.1%. Five of the twelve categories sold more, with Workwear & Safetywear (+10.0%) up the most. Renewables & Water Saving (-28.9%) was the weakest performing category. With one less trading day this year, like-for-like sales were down -5.2%.

Total Merchants sales were -8.1% lower in August than in July 2024.

Volume sales were -9.2% down and prices were +1.2% up.

Latest three months v previous three months: June 2024 - August 2024 v March 2024 - May 2024

Total sales in June to August 2024 were +2.0 higher than in March to May 2024. Volume sales were up +3.6% but prices were down -1.6%. Seven of the twelve categories sold more with Heavy Building Materials (+3.5%), Services (+3.2%) and Decorating (+2.3%) ahead the most. Timber & Joinery Products (+1.9%) performed just below Total Merchants (+2.0%). Workwear & Safetywear (-6.0%) and Plumbing Heating & Electrical (-6.1%) were weakest. With two more trading days this period, like-for-like sales were -1.2% lower.

Year-to-date v last year: January 2024 to August 2024 v January 2023 to August 2023

Total sales in January to August 2024 were -5.4% lower than the same period last year. Volume sales were -6.5% down with prices slightly up (+1.2%). Five of the twelve categories sold more with Workwear & Safetywear up most, by +13.8%. But the two largest categories Heavy Building Materials (-7.3%) and Timber & Joinery Products (-7.7%) sold less. Renewables & Water Saving (-28.0%) was weakest. With two more trading days this period, like-for-like sales were -6.5% lower.

Latest 12 months v last year: September 2023 - August 2024 v September 2022 - August 2023

Total value sales in the last 12 months, September 2023 to August 2024, were -5.7% down on the previous period, September 2022 to August 2023. Volume sales were -8.5% down with prices up +3.1%. Workwear & Safetywear (+10.4%) was up the most, followed by Miscellaneous (+4.6%) and Decorating (+4.5%). The two largest categories Heavy Building Materials (-7.5%) and Timber & Joinery Products (-9.0%) declined more than Total Merchants. Renewables & Water Saving (-19.9%) was weakest. With three more trading days this period, like-for-like sales were -6.8% lower.

Total value sales in the last 12 months, September 2023 to August 2024, were -5.7% down on the previous period, September 2022 to August 2023.

Volume sales were -8.5% down with prices up +3.1%.

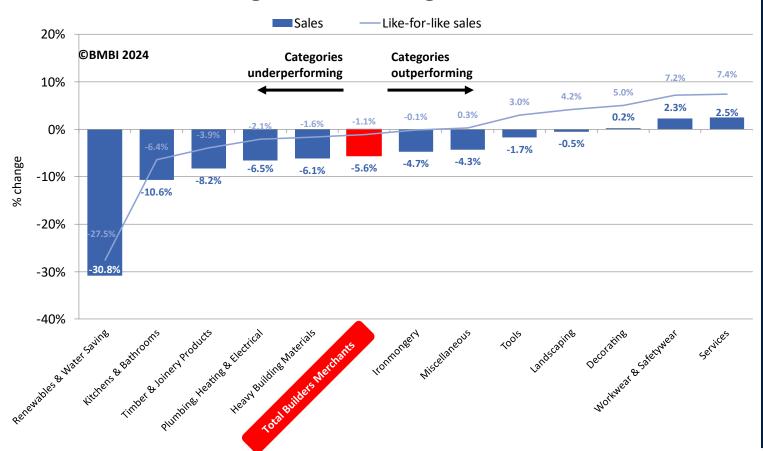

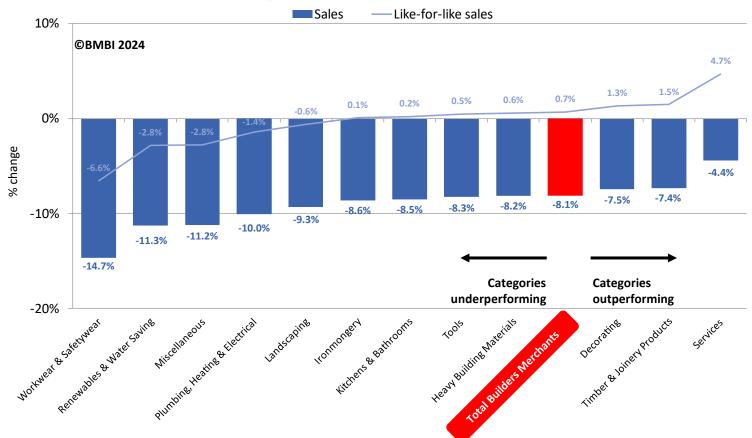

August 2024 v July 2024



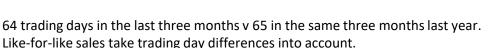

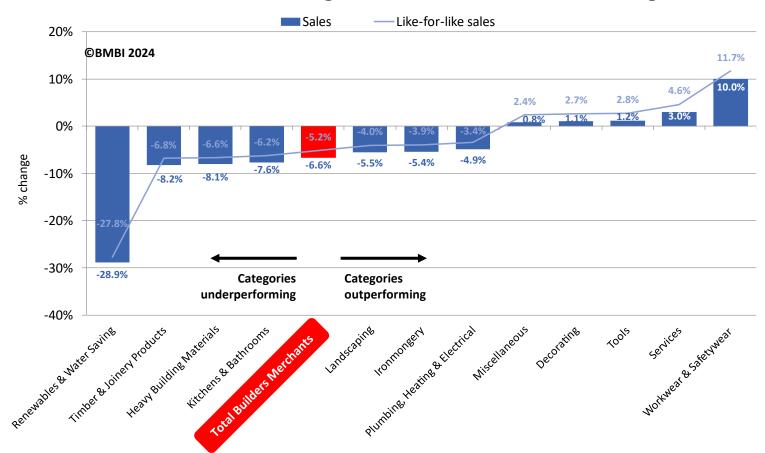

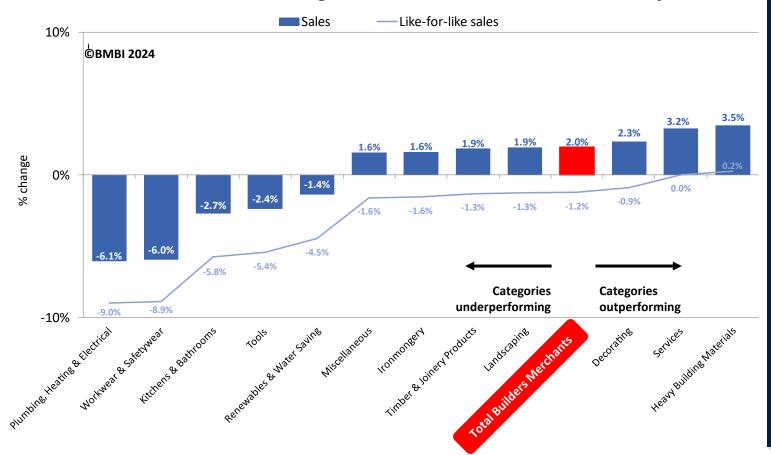

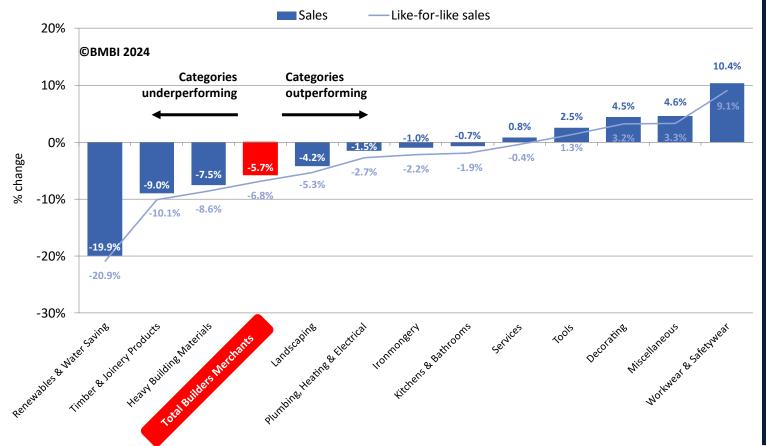

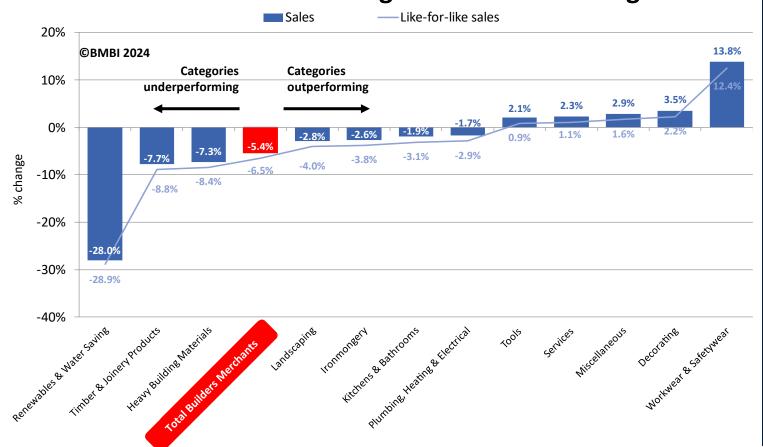

GfK's Definition of Builders Merchant Panel





Generalist Builders Merchants definition:

- Builder Merchants handle an extended range of building materials and components (e.g. doors, windows, interior furnishing materials, insulation materials, tiles, cement, mortar, adhesives, sealants, nails, hardware products, pipes, ironware, paint) and generate their turnover with professional end users. Only multiple merchants are considered; they are defined as having more than 3 outlets or a turnover of greater than £3m p.a.
- This excludes branches that generate all their sales from specialized areas such as Civils, Tiles and Tools. Estimated coverage of this channel sits at 88%.

Builders Merchants Industry Forecast Report

The latest forecast report of the BMF's Builders Merchants Industry Forecast, covering Summer/Autumn 2024 onwards, is available.

While Builders Merchants Building Index (BMBI) data, which is provided by GfK and is based on actual sales category performance, has enabled users to see which products and regions are currently growing, the forecast report takes this one stage further to meet the industry's need for accurate forecasting.

The BMF forecast model incorporates several lead indicators to signal future events that will impact our markets.

Using BMBI data coupled with advanced modelling techniques the BMF has developed a channel-specific forecasting model to show what is likely to happen in the next 12 months, making it possible for merchants and suppliers to forecast their customers' requirements more accurately.
